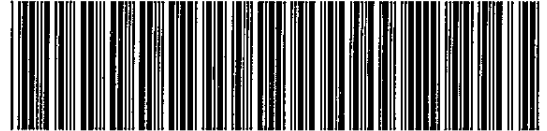

MOHLMAN, being the Vice-President and sole shareholder of AIC Performance, Inc., a Florida corporation (the "Corporation"), incorporated October 22, 1996 under Document No. P96000087274, does hereby certify, attest and serve notice, pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, that the Corporation adopts the following Articles of Amendment to its Articles of Incorporation: on March 23, 2005.


FIRST: Article I of the Articles of Incorporation of the Corporation is hereby amended to provide that the new name of the Corporation is INITRAM SERVICES, INC.;
