ARTICLES OF INCORPORATION

OF

J. MICHAEL ENTERPRISE, INC.

The undersigned incorporator of these Articles of Incorporation, natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is J. MICHAEL ENTERPRISE, INC.

ARTICLE II. PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business in the State of Florida including those contained in Florida Statute Chapter 607.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock this corporation is authorized to have outstanding at any one time is 20 Shares of common stock having a nominal or par value of \$1.00 per share.

ARTICLE IV. PREEMPTIVE RIGHTS

ARTICLE VII. INITIAL REGISTERED OFFICE AND AGENT
