The above company was formed to obtain contracts of Education Tuition Television Programs from Floridian Artists for export to Southern Africa.

Regrettably after 4 years of trying to finalize the deal with the Zimbabwe Broadcasting and Television Network, we could not overcome the problems of guarantees and payments. Their currency has devalued astronomically and their economy is on the decline. They are unable to pre-pay their orders and experience (having lived there for 35 years) has taught me not to extend credit on trust.

So after four years of keeping my dream alive by paying annual filing fee for a dormant company, I have decided to abandon this project.

Unless I am obliged by law to purchase copies of the dissolution or certificate of status, I do not wish to order any certified copies, which would just add to my expenses.
