The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The Name of the Corporation is FINANCIAL SERVICES, INC. OF OCALA.

The duration of the corporation is perpetual.

ARTICLE THREE

Purposes
