ARTICLES OF INCORPORATION

OF

GEORGE'S 99 CENTS PLUS, INC.



LAWRENCE BROWN, a natural person competent to contract does hereby subscribe, acknowledge and file in the offices of the Secretary of the State of Florida for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida, these Articles of Incorporation as by law provided.

ARTICLE I

NAME

The name of this Corporation shall be as stated above.

ARTICLE II

GENERAL NATURE OF BUSINESS

This Corporation may engage in any activity or business permitted under the laws of the United States of America and the State of Florida, including but not limited to RETAIL SALES.

ARTICLE III

CAPITAL STOCK

The maximum capital stock authorized to be issued by this Corporation shall be ONE THOUSAND (1000) SHARES having a par value of ONE (1) DOLLAR per share.
