Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is EQUITY ONE (MONUMENT) INC. (the "Corporation"), Charter # P96000087645.

2. The following Amendment to the Amended and Restated Articles of Incorporation was adopted by the Unanimous Written Consent of the Directors and the Sole Stockholder of the Corporation, on February 6, 2003 in the manner prescribed by Section 607.1003 of the Act.

3. Article V, Section 4(k) of the Corporation's Amended and Restated Articles of Incorporation is hereby deleted in its entirety.

4. Article V, Section 4(l) of the Corporation's Amended and Restated Articles of Incorporation is hereby deleted in its entirety.

4. Except as hereby amended, the Amended and Restated Articles of Incorporation of the Corporation shall remain the same.

5. The effective date of this amendment shall be upon the filing of these Articles of Amendment.
