ARTICLES OF INCORPORATION
OF

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles Of Incorporation.

ARTICLE I - NAME

The name of this Corporation is N.J. TRUCK SYSTEMS, INC.

ARTICLE II - NATURE OF BUSINESS

The Corporation will provide Trucking and Transportation and Related Products and Services to Businesses and the Public.

ARTICLE III - CAPITAL STOCK
