## ARTICLES OF INCORPORATION

OF

J. S. & D, INC.

The undersigned Incorporator of these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles of Incorporation, for the formation of a corporation under the applicable Laws of the State of Florida.

### ARTICLE I

#### NAME

The name of this corporation will be J. S. & D., Inc.

### ARTICLE II

#### NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the Laws of the United States and the State of Florida.

### ARTICLE III

#### CAPITAL STOCK

The maximum shares of stock this corporation is authorized to have outstanding at any one time is SEVEN THOUSAND, FIVE HUNDRED SHARES (7,500) shares), all of which shall be voting Common Stock with a par value of ONE and 00/100 DOLLAR, (\$1.00).

To the extent permitted by law, said stock shall be issued pursuant to a plan under Section 1244 of the Internal Revenue Code as amended.

All said stock shall be payable in cash or in services or in property other than stock or securities in lieu of cash at a just valuation to be determined by the shareholders of this corporation at any regular or special meeting.

ARTICLE IV  
INITIAL CAPITAL

The amount of capital with which this corporation shall begin business shall not be less than ONE HUNDRED and 00/100 DOLLARS, (\$100.00).

ARTICLE V  
TERM OF EXISTENCE

This corporation is to exist perpetually.

INITIAL OFFICE AND REGISTERED AGENT



DESIGNATION OF REGISTERED AGENT


