

ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of the corporation is A & D LANDSCAPING AND CLEANING SERVICES, INC.

ARTICLE II - DURATION

This corporation is to exist perpetually.

The power to adopt , alter , amend or repeal by-laws shall be vested in the Board of Directors.


ARTICLE XII - INDEMNIFICATION

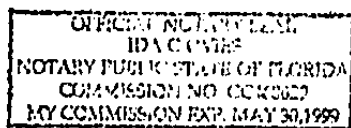


