ARTICLE I - NAME

The name of this Corporation is LOCATION MARKET TECHNOLOGY, INC., with its principal place of business located at 2450 Hollywood Boulevard, Suite 606, Hollywood, Florida 33020.

ARTICLE II - DURATION

This Corporation shall have perpetual existence. The effective date of this Corporation shall be the date of its registration with the Secretary of State.

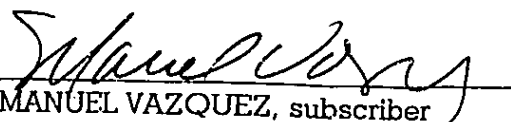
ARTICLE IX - INDEMNIFICATION
