ARTICLES OF INCORPORATION OF P.D. INVESTMENTS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

NAME, PRINCIPAL PLACE OF BUSINESS AND DURATION

The name of the Corporation is P.D. INVESTMENTS, INC. The principal place of business of the Corporation is 5412 STEVEN RD. BOYNTON BEACH, FL. 33437. The duration of the Corporation is perpetual.

ARTICLE II

REGISTERED OFFICE AND AGENT
