## ARTICLE I NAME AND MAILING ADDRESS

The name of the Corporation is DRYCLEAN EXPRESS OF SOUTH FLORIDA, INC. The mailing address for the corporation is 4286 S.W. 49th Court Fort Lauderdale, Florida 33314.

#### ARTICLE II TERM OF EXISTENCE
