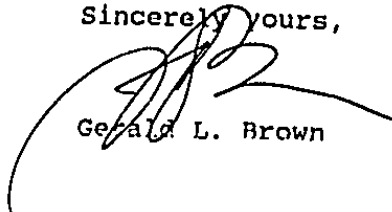

ARTICLES OF INCORPORATION
OF

ARTICLE ONE - NAME

The name of the corporation is WESTWOOD CAMPING CENTER, INC.

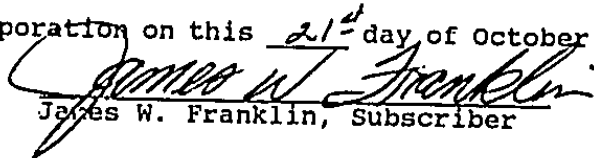
ARTICLE NINE - BY-LAWS
