The undersigned subscribers to these Articles of Incorporation, SANDRA TAYLOR and ARQUIMIDES GUERRERO hereby form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is TROPICAL CUSTOM AIR, INC.

ARTICLE II - TERM OF EXISTENCE

This corporation shall begin as of the date of the complete execution and acknowledgment of these Articles, and shall have a perpetual existence.

ARTICLE III - NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STRUCTURE
