The undersigned incorporators hereby forms a corporation under Chapter 607 of the Laws of the State of Florida.

ARTICLE I

The name of the corporation shall be:

BROMAX, INC.

ARTICLE II

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

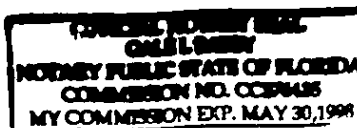

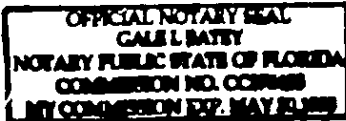

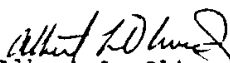
