The undersigned, certifies that:

1. She is the President of STAFFED, INC., a Florida corporation, whose Articles of Incorporation were filed with the Secretary of State, State of Florida, on October 25, 1996.

2. The following Amendment to the Articles of Incorporation was unanimously adopted and approved by the Shareholders and the Board of Directors, by written consent in lieu of a meeting, dated March 21st, 2000.
