ARTICLE 1: NAME AND MAILING ADDRESS

The name of this Corporation is YBOR CITY BRIEWING COMPANY, INC., and its principal office or mailing address is 2205 North 20th Street, Tampa, FL 33605.

ARTICLE 2: DURATION
