The Undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

Article 1. Name and Address. The name of the Corporation is: APPRAISAL SERVICES OF SW FL, INC. The principal office of the Corporation is:
