The undersigned incorporators to these Articles of Incorporation hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation is: MAKES CENTS OF CENTRAL FLORIDA, INC.

ARTICLE II. COMMENCEMENT AND DURATION

Corporate existence of this corporation shall commence on November 1, 1996, and this corporation is to exist perpetually.




