Article 1. Name. The name of the corporation is:
Fatimah Corporation

Article 2. Principal Office. The principal office of the corporation shall be located at: 5819 State Road 674, Wimauma, Florida 33598.

Article 3. Stock. The number of shares the corporation is authorized to issue is one thousand (1000). There shall be one class of shares, which is common, and each share shall have a par value of \$1.00. The rights of each shareholder shall not vary as to relative rights and preferences among shares. The corporation elects to have preemptive rights.


Article 8. Effective Date. The effective date of the corporation shall be the date of filing of the Articles of Incorporation by the Department of State.
