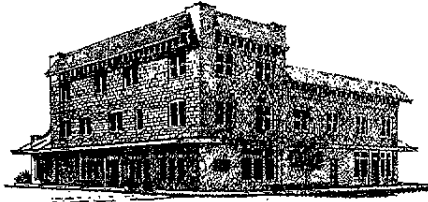

1. That the name of the corporation is MORRISON CHIROPRACTIC, P.A.



2. The Articles of Incorporation of said corporation are amended as follows:

5. The number of votes cast for the Amendment by the Shareholders was sufficient for approval, there being no more than one voting group entitled to vote thereon.


