The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

NAME, PRINCIPAL PLACE OF BUSINESS AND DURATION

The name of the Corporation is SHREEJEE CORPORATION OF ORLANDO. The principal place of business of the Corporation is 7219 CURRYFORD ROAD ORLANDO, FL. 32822. The duration of the Corporation is perpetual.

ARTICLE II

REGISTERED OFFICE AND AGENT

The address of the registered office in the state of Florida is 7219 CURRYFORD RD.in the city of ORLANDO in the County of ORANGE. The name of the registered agent at such address is NITIN B.PATEL.

ARTICLE III

CORPORATE PURPOSE, POWERS AND RIGHTS
