ARTICLE I - Name

The name of this corporation is COMPUTEMP OF JACKSONVILLE, INC.

ARTICLE II - Duration

This corporation shall exist perpetually.

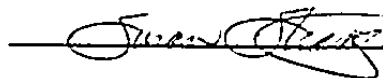

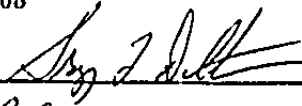
