The name of the corporation is ALCO TRUCK REPAIRS, INC.

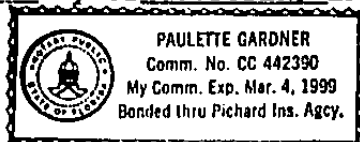
