ARTICLES OF INCORPORATION

<u>OF</u>

HOMESTEAD TAX COMPANY, INC.

ARTICLE I

The name of this corporation is HOMESTEAD TAX COMPANY, INC.

ARTICLE II PURPOSE

This corporation is organized for the following purposes:

1. To engage in any activity or business permitted under the laws of the United States and the State of Florida.
