



Dear Sir or Madam:

On April 1, 2003, I mailed our UBR for 2003 together with a company check in the amount of \$150.00 (check number 7697) to the Division of Corporations. In late April, I noticed that the check had still not cleared so I contacted your office to inquire as to whether you had received our package. I was advised that your office was back-logged and that it was likely that the payment and UBR had not been processed. I checked again today and found that our check has still not cleared.
