## ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation.

## ARTICLE I - NAME

The name of the Corporation is **HEDI ENTERPRISES**, INC. The mailing address is: 3250 U.S. Highway 17, Yulee, FL 32097.

### ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

## **ARTICLE III - PURPOSE**

This Corporation is organized for the purposes of transacting any or all lawful business.

### ARTICLE IV - CAPITAL STOCK
