ARTICLES OF INCORPORATION

OF

SECRETARY OF STATE TALLAHASSES, FLORIDA

LEONARD PROPERTY CORP.

The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

ARTICLE I -NAME

The name of the corporation shall be Leonard Property Corp.

ARTICLE II - COMMENCEMENT & DURATION

The corporation shall commence its existence on October 29, 1996 and shall exist perpetually unless sooner dissolved according to law.

ARTICLE III - ADDRESS

The mailing address of the corporation is 9300 NE 4 Ave. Miami Shores FL 33138.

ARTICLE IV - STATED CAPITAL

The corporation is authorized to issue the following capital stock:

Subject to applicable Florida statutes, every Shareholder, upon the sale of any new stock of the corporation of the same kind, class or series as he or she already holds, shall have the

right to purchase his or her pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE V - REGISTERED AGENT

The name and address of the Registered Agent of the corporation is Thomas A. Leonard, 9300 NE 4 Ave. Miami Shores FL 33138.

ARTICLE VI - INCORPORATOR

The name and address of the incorporator of the corporation is Thomas A. Leonard, 9300 NE 4 Ave. Miami Shores FL 33138.

ARTICLE VII - BOARD OF DIRECTORS

The corporation shall have one director initially. The number of directors may be increased or decreased from time to time thereafter according to the bylaws of the corporation but shall never be less than one. The name and street address of the initial director of this corporation is Thomas A. Leonard, 9300 NE 4 Ave., Miami Shores FL 33138.

ARTICLE VIII - SHAREHOLDER PROPERTY

Private property of the shareholders shall not be subject to the payment of the corporation's debts. The corporation shall have a first lien on the shares of its shareholders and upon the dividends due them for any indebtedness of the shareholders to the corporation.

ARTICLE IX - AMENDMENTS TO ARTICLES

The Directors shall have the power to amend or repeal these Articles of Incorporation with not less than a two-thirds vote of the common stock.
