The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under chapter 607 of the Florida statutes.

ARTICLE 1-NAME

The name of the Corporation is : ALUMINUM SPECIALIST ENTERPRISE INC..

ARTICLES 2- NATURES OF BUSINESS

The corporation shall engage in any activity or business permitted under the laws of the United States of and of the State of Florida.

ARTICLE 3- PRINCIPAL OFFICE

ARTICLES 4- INCORPORATION

ARTICLES 5- CORPORATE CAPITALIZATION

5.1 The maximum number of shares that this corporation is authorized to have outstanding at any time is one thousand (1000) shares of common stock, each share have a par value of one dollars (\$1.00)

5.2 No holder of share of stock of any class shall have and preemptive right to subscribe to or purchase any additional shares of any class, or any bonds or convertibles securities of any nature; provided, however, that the board of directors may, in authorizing the issuance of shares of stock of any class, confer any preemptive right that the board of directors may deem advisable in connection with such issuance.

5.3 The board of direction of the Corporation may authorize the issuance from time to time of shares of its stock of any class, whether now or hereafter authorized, for such consideration as the board of directors may deem advisable, subject to such restriction or limitations, if any, as may be set forth in the by law of the corporation.

5.4 The board of directors of the corporation may, by articles supplementary, classify or reclassify any unissued stock from time to time by setting or change the preference, conversion or other rights, voting power, restriction, limitation as to dividends, qualification, or term or conditions of redemption of the stock.

ARTICLES 6- POWER OF CORPORATION

The corporation shall have the same power as an individual to do all things necessary or convenient to carry out its business and affairs, subject to any limitations or restriction imposed by applicable law or these Articles of Incorporation.

ARTICLES 7- TERM OF EXISTENCE

The corporation shall have perpetual existence.

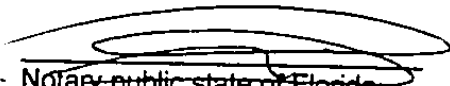
