ARTICLES OF INCORPORATION
OF
MARTINEZ INSPECTION SERVICES, INC.

The undersigned hereby execute(s) and acknowledges the incorporation in order to organize and incorporate a business for profit.

ARTICLE I - NAME

The name of the corporation is MARTINEZ INSPECTION SERVICES, INC., with its principal place of business located at 7805 West 29th Lane, Suite 101, Hialeah, FL 33018.

ARTICLE II - PURPOSE

The purpose of this corporation is to engage in any or all lawful business activity for which a corporation is permitted under the laws of the United States of America and of the State of Florida.

They shall serve for a period of one year or until their successor(s) are elected.


ARTICLE IX - DISSOLUTION
