ARTICLE VIII. PRE-EMPTIVE RIGHTS

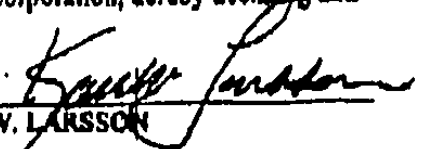

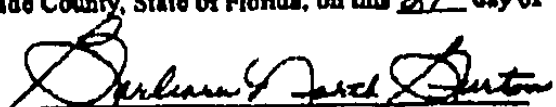

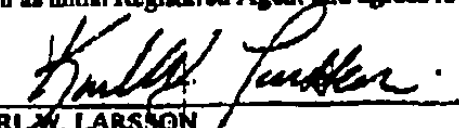
