#### ARTICLES OF INCORPORATION

OF

#### SMELLY SQUID, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is SMELLY SQUID, INC.. The principal place of business of the corporation shall be 6107 Yates Rd., Lakeland, FL 33811.

SECOND: The period of duration of the corporation is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and of this State.

FOURTH: Authorized Shares.
