I, BRUCE LASTER, being of legal age, do hereby sign these presents for the purpose of becoming a Corporation under the laws of the state of Florida authorizing the formation of Corporations.

These Articles of Incorporation are to be effective on the _____ day of _____, 19___. (If no date is inserted, these Articles are to be effective as of the date of filing with the Secretary of State).

ARTICLE I
