#### ARTICLE I - NAME:

A

The name of this corporation is: WINNER PRODUCTIONS, INC. hereinafter referred to as the ("Corporation").

## ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.

#### ARTICLE III - PURPOSE:
