ARTICLES OF INCORPORATION  
OF CHRIS TUCKER ENTERPRISES, INC.

The undersigned has executed the following Articles of Incorporation as incorporator under the laws of the state of Florida.

ARTICLE I. Name. The name of the corporation shall be Chris Tucker Enterprises, Inc.

ARTICLE II. Term. The existence of the corporation shall commence upon the filing of these Articles of Incorporation with the Department of State. The corporation shall have perpetual existence.

ARTICLE III. Purpose. The purpose of the corporation shall be to transact any and all business authorized by law.

ARTICLE IV. Shares. The corporation shall be authorized to issue 100 shares of voting common stock which shall have no par value. The corporation shall be authorized to issue 1000 shares of non-voting preferred stock having no par value. The Board of Directors shall have authority to establish series and fix the relative rights and preferences. The shareholders shall have pre-emptive rights.

ARTICLE V. Registered Agent and Office. The Registered Agent of the corporation shall be Luther Christopher Tucker, III, who acknowledges acceptance of his position as Registered Agent by execution hereof.

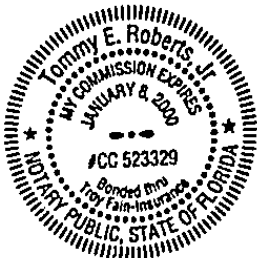
