ARTICLE I. NAME

The name of the corporation shall be:

The Board of Directors may be changed in accordance with the By-laws, at the direction of the shareholders of common voting stock.

ARTICLE VIII. INDEMNIFICATION

ARTICLE IX. BY-LAWS and AMENDMENTS
