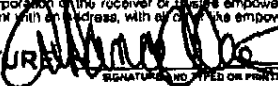

Dear Department of State,

I am writing this letter to address a serious situation on the behalf of my corporation. I have recently (today July 14, 2003) received my 2003 Uniform Business Report. This was the first time I received this notice. In mid 2002, I changed my PO Box from PO Box 103 Indian Rocks Beach FL 33785 to PO Box 14524 Clearwater, FL 33776. When I switched my PO Box address I sent out notifications to all of my vendors. It appears that the Division of Corporations never changed my address in their system since this is the first notice that I have received about the 2003 Uniform Business Report. I properly filed change of address forms and filed a forwarding address requests. However, I did have some problems with my mail route. I also had issues with my former PO Box in regards to forwarding some of my mail. I tried to the best of my ability to resolve these issues. However, there were some problems accounting for all of my mail. In the move, I made sure to address all filing requirements which I received mail correspondence for. For the record, I did properly and timely file my quarterly Florida Unemployment Tax reports. I did attempt to comply with all filing requirements.

As soon as I received this annual report, I researched the issue. I researched my account history on the website after speaking with someone at the Division of Corporations. I soon discovered that the mailing address of record on the website (PO Box 103 Indian Rocks Beach FL 33785) was my old address. So, the annual corporate report must have been mailed to that address and NEVER forwarded to me new address. I am writing to ask for some understanding on this issue given my filing history, earnest attempt to correct the situation and honesty. I am writing to request a fair resolution to this error. I would have filed these forms if I would have received them in the mail properly. I understand the filing requirements now and promise to comply with them in the future.

I am sending in the annual renewal of \$150.00 along with the annual report. I am a small business owner who has made a mistake via the mail system. Please accept this payments and reinstatement my corporation. This situation has caused me great stress and worry. I am working hard every single day just to survive and make it in the business world. Please give me an opportunity to resolve this issue fairly and move on. I respect you understanding in this unforeseen incident.
