## AMENDMENT TO ARTICLES OF INCORPORATION OF GROUP INFOTECH, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned corporation submits and adopts the following Amendment to Articles of Incorporation:

FIRST: The name of the Corporation is GROUP INFOTECH, INC.

**SECOND:** The Articles of Incorporation of this Corporation are amended by changing "Article IV" so that, as amended, said Article shall read as follows:

"This Corporation is authorized to issue two classes of common stock: Class A voting common stock and Class B non-voting common stock. The Corporation is authorized to issue 1,000,000 shares of Class A voting common stock and 500,000 shares of Class B non-voting common stock.

Each share of issued and outstanding Class A common stock shall entitle the holder thereof to fully participate in all shareholder meetings, to cast one vote on each matter with respect to which shareholders have the right to vote, and to share ratably in all dividends and other distributions declared and paid with respect to the common stock, as well as in the net assets of the corporation upon liquidation or dissolution."

THIRD: The date of adoption of the Amendment is February 18, 1999

**FOURTH:** The Amendment to Article IV was approved by the shareholders and adopted by the Directors.
