## ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

### ARTICLE I

#### Name

The name of the corporation shall be:

Glades Junior & Senior Rifle & Pistol Club, Inc.

### ARTICLE II

#### Principal place of business and mailing address

The principal place of business and mailing address of this corporation shall be:

### ARTICLE III

#### Purposes(s)

The specific purpose(s) for which the corporation is organized is (are):

The corporation is formed exclusively for purposes for which a corporation may be formed under the Corporation Not For Profit Law and not for pecuniary profit or financial gain. No part of the assets, income, or profit of the Corporation shall be distributable to, or inure to the benefit of, its members, directors, or officers except to the extent permitted under the Corporation Not For Profit Law.

The Club will also encourage education and training in the use of firearms for sport, with the emphasis on safety, and the safe manner in which the firearms can be utilized for competitive sporting activities via marksmanship competitions, etc.

The corporation will also encourage the proper organization, operation, and administration of member clubs; to promote and coordinate statewide activities related to the ownership and

lawful use of firearms, and the promotion of the highest degree of sportsmanship and good fellowship among the membership of the Club, and to prevent the occurrence or tolerance of unsportsmanlike conduct.

#### ARTICLE IV

##### Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

The method of election of directors shall be as stated in the bylaws.

Initial Directors: The number of Directors constituting the initial Board of Directors shall be 4, and the names and addresses of the persons who are to serve as Directors until the first meeting of the Corporation or until their successors are elected and qualified are:


