ARTICLES OF INCORPORATION OF

ARTICLE I - NAME

The name of this corporation is Curl Allen's Florida State Championship Bluegrass Festival, Inc.

ARTICLE II - DURATION

This corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this corporation is to engage in any activities of business permitted under the laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 7,500 shares of common stock having a par value of one dollar (\$1.00) per share.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of this corporation shall be 1387 Highway 92 East, Auburndale, Florida 33823, and the initial registered agent of this corporation at such office shall be JEWELL W. ALLEN, who upon accepting this designation agrees to comply with the provisions of Section 48.091,

Florida Statutes as amended from time to time, with respect to keeping an office open for service of process.


