I, the undersigned natural person, acting as incorporator of a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

**ARTICLE ONE**

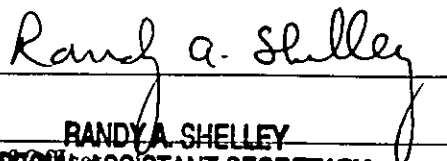
