

The shareholders of the Corporation approved the dissolution of the Corporation on December 22, 2003.


ARTICLE III

The total number of votes cast by the shareholders of the Corporation in favor of dissolution was sufficient to approve the dissolution of the Corporation. No voting by voting groups was required.


ARTICLE IV
