ARTICLES OF INCORPORATION OF

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I - NAME & PRINCIPAL OFFICE

The name of the corporation is *I L D T, Inc.* and its principal office is located at 300 W. Sunrise Boulevard, Suite 1, Fort Lauderdale, Fl 33311.

ARTICLE II - DURATION

This corporation shall commence its existence upon receipt of these articles by the Secretary of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawfull business.

ARTICLE IV - CAPITAL STOCK
