The undresigned, desiring to form a Corporation for the purposes hereinafter stated, under and pursuant to Chapter 607 bt the Florida Statutes, do hereby declare as follows:

I. NAME

The name of the Corporation shall be FAST FORWARD FINANCIAL SERVICES, INC.
