ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is
VIEUX MALINES, INC.

ARTICLE II - DURATION

The duration of the corporation is perpetual.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and/or lawful business including, but not limited to, Restaurant Business.

ARTICLE IV - CAPITAL STOCK

The aggregate number of shares which the corporation is authorized to issue is 7500 shares of common stock. Such shares shall be of a single class and have no par value.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 37837 Meridian Ave. Dade City, Florida 33525, and the name of its' initial registered agent at that address is Rudolf Victor Adrienne Van Hoof. The corporation's principal address and mailing address is the same as the corporation's initial registered office address.

ARTICLE VI - THE INITIAL BOARD OF DIRECTORS

The number of directors constituting the initial board of directors is one. The number of directors may be increased or decreased from time to time in accordance with the by-laws, but shall never be less than one. The name and address of each initial director of the corporation is as follows:

ARTICLE VIII - AMENDMENT

The corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and any right conferred upon the shareholders is subject to this reservation.

ARTICLE IX - INDEMNIFICATION

The corporation shall indemnify each office and director, including former officers and directors, to the full extent permitted by law.

ARTICLE X - THE RIGHT OF THE INITIAL DIRECTOR

The initial director shall have the right to be a director of the corporation as long as that respective director is a shareholder of the corporation.

ARTICLE XI - BY-LAWS

The power to adapt, alter, amend, and repeal the by-laws shall be vested in the board of directors, but all alterations, amendments, and repeals of the by-laws must be approved by a majority of the shareholders.

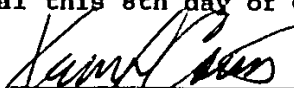

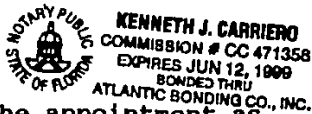
