ARTICLE XI INDEMNIFICATION

The corporation shall indemnify any officer or director, to the full extent permitted by law.

ARTICLE XII DISSOLUTION

The corporation may be dissolved at any time on the affirmat vote of the holders of at least two thirds (2/3) of the outstanding shares of the corporation entitled to vote thereon.
