1.01 The name of the Corporation is J.R.C. Enterprises of Tampa, Inc.

ARTICLE II

(Nature of Business)

2.01 The corporation may engage in any activity or business that

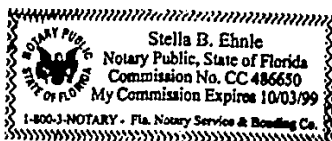
