I have been notified that the above referenced corporation is inactive.

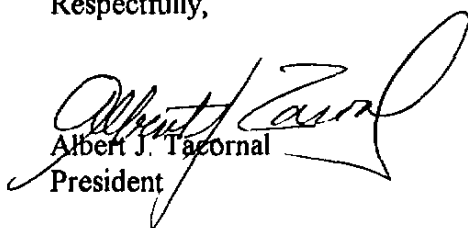
In order to activate the corporation, I am subject to penalties which total over \$500.00. I never received any correspondence from your office regarding the renewal of the corporation.

I latter learned that the Florida Division of Corporations had the wrong address in its files. See attached documents submitted to your office with the correct address which is: 9621 SW 100th Avenue Miami, FL 33176. All the documents had the correct address and at the time the corporation was registered with the Florida Department of State, but the Department made an error when recording the address in its records.
