OF

The undersigned, acting as incorporator, signs the following Articles of Incorporation for the purpose of forming a general conventional corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be:

OMEGA PARTNERS, INC.

ARTICLE II

The existence of the corporation shall commence upon the filing of these Articles of Incorporation by the Department of State and shall be perpetual.

ARTICLE III

The general purposes for which the corporation is initially organized are:

To engage in any lawful business under the laws of the United States and the State of Florida, and in connection therewith and in furtherance thereof, to possess and exercise all the powers and privileges granted by the Florida General Corporation Act or by any other law of Florida or by these Articles of Incorporation together with any powers incidental thereto.

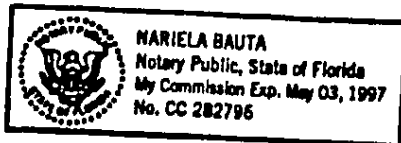
