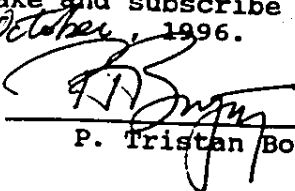

INDEMNIFICATION

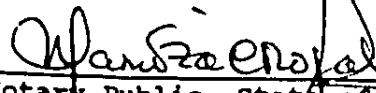
